## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to carry out extraction activities and preparation for sale of crustaceans attached to rocks in areas of high waves, while complying with health and safety requirements and environment prevention measures. This general competence is divided into the following **skill units(UC)**:

- Contribute to the in deck operations on a fishing boat (UC0010\_1).
- Perform extraction activities and preparation for sale of crustaceans attached to rocks in areas of high wave exposure (UC1889\_1).
- Participate in maritime emergencies and implement safety standards at work (UC0733\_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- On deck operations in a fishing vessel (MF0010\_1).
- Extraction and preparation work for the sale of crustaceans attached to rocks (MF1889\_1).
- Safety and first aid on board (MF0733\_1).
- Practical training at the workplace in extraction and harvesting activities of crustaceans attached to the rocks (MP0529).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Participate with security, in the extraction and harvesting of crustaceans attached to the rocks operations, according to the management plans and/or fish stock.
- Participate in the works of preservation for the sale of crustaceans attached to the rocks, respecting quality standards and hygienic-health regulations.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the field of fishing and shellfishing, and specifically in the productive activities of resource extraction. The most relevant occupations and work positions are:

- Sailor in fishing vessel.
- Sailor.
- Fisherman sailor.
- Barnacle collector on board.
- Barnacle collector on foot.

The holder of this professional certificate can be recognised by the title of fishing sailor according to Royal Decree 36/2014, which regulates the professional titles of fishing sector, following the established procedure and the authorised centers.

## 5. OFFICIAL BASIS OF THE CERTIFICATE

### Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

### Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

### Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

### Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

### Legal basis

Royal Decree 988/2013 of December 13th, by which nine professional certificates of the professional family of Maritime and Fishing Industry included in the National Repertoire of professional certificates are established, and the professional certificates established as Appendix IV of the Royal Decree 1774/2011, of December 2nd, and Appendix III of Royal Decree 1533/2011 of October 31st are updated. (Appendix II, Code: MAPN0112)

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
