3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to carry out repairs and alterations to textile and leather clothes, as well as household linen, applying specific techniques and processes, ensuring the article acquires the required finish with quality, without supervision or if necessary with the supervision of a superior, within the time limits and in conditions of safety, providing the appropriate service for customers asking for the work. This general competence is divided into the following **skills units** (UC):

- Serve customers when providing repair and alterations of textile and leather goods (UC1224_1).
- Prepare textile cutting and sewing materials, tools, machines and equipment (UC1225_1).
- Carry out repairs to clothing and household linen (UC1226_1).
- Carry out alterations and personalise clothing (UC1227_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Information and customer service in repair and alteration services for textile and leather goods (MF1224_1).
- Textile cutting and sewing materials, tools, machines and equipment (MF1225_1).
- Alterations in clothing and household linen (MF1226_1).
- Alterations and personalisation of clothing (MF1227_1).
- Practical training at the workplace repair and alterations of textile and leather clothes and goods (MP0210)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Take part in customer service activities for the repair and alteration service of textile and leather articles.
- Prepare the cutting and sewing materials, tools, machines and equipment needed for repair and alterations to textile and leather articles, acting in accordance with safety regulations.
- Carry out repairs, alterations or personalisation of textile and leather articles, based on technical documentation, using the necessary tools and machines, and under appropriate safety conditions.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the clothing and fashion sector, in companies dedicated to repair, alteration and personalisation of clothing and textile and leather articles: companies linked to the clothing and fashion industry, such as tailors, dressmakers, haute couture, or in the production of live performances. The most pertinent occupations and positions are:

- Hand or domestic machine sewer, in general.
- Hand mender.
- Dressmaker for repairs and alterations.
- Tailor/fabric mender.
- Garment worker.
- Dressmaking worker.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 722/2011 of 20 May, establishing five professional certificates in the professional family Textile, Clothing and Leather, which are included in the National Repertoire of Professional Certificates. (Appendix II, Code: TCPF0109)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
