3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to assemble aircraft structures and install aircraft systems and equipment, including operations of disassembly, mechanisation, cleaning and sealing of deposits and other elements to be joined; and to connect calibrate and check flight equipment, following instructions from senior technicians and established procedures; while complying with quality criteria and standards, the company's occupational risk prevention and environmental plans and applicable law. This general competence is divided into the following **skills units** (UC):

- Assemble aircraft structures (UC1850_2).
- Seal structural aircraft elements (UC1851_2).
- Install aircraft systems and equipment (UC1852_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Assembly of structural aircraft elements (MF1850_2)
- Sealing of structural aircraft elements (MF1851_2)
- Installation of aircraft systems and equipment (MF1852_2)
- Practical training at the workplace in assembly of aircraft structures and installation of systems and equipment (MP0430)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Assemble elements of aircraft structures according to technical documentation and applying standards governing quality, occupational risk prevention and environmental protection.
- Seal elements of aircraft structures according to technical documentation and applying standards governing quality, occupational risk prevention and environmental protection.
- Assemble elements of aircraft equipment and systems according to technical documentation and applying standards governing quality, occupational risk prevention and environmental protection.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies dedicated to the construction of aircraft structures and their repair. The holder may work in the aircraft and aerospace construction sectors, including machine construction, and aeronautical and aerospace repair and maintenance.

The most pertinent occupations and positions are:

- Installer of piping in general.
- Metal plotter.
- Aircraft electrician.
- Assembler of aircraft structures.
- Installer of aero-mechanical systems.

The certificate is valid throughout Spain.</p>
<p style="text-align: center;">Level of the certificate</p> <p>The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>
<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10

<p style="text-align: center;">Legal basis</p> <p>Royal Decree 1078/2012 of 13 July, establishing two professional certificates in the professional family Mechanical Manufacturing, which are included in the National Repertoire of Professional Certificates. (Appendix I, Code: FMEA0111)</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
