## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to run games of blackjack, draw poker and straight poker, baccarat, American roulette and French roulette, to arbitrate and guarantee their transparency at all times and to carry out auxiliary operations, checking the bets, running the games and paying players the prizes corresponding to their winning bets, guided by a superior; while complying with the law at all times, within the framework of the organisation's procedures and rules governing occupational risk prevention. This general competence is divided into the following **skills units** (UC):

- Engage in complementary activities to running table games in casinos (UC1769\_2).
- Run blackjack games (UC1770\_2).
- Run draw poker and straight poker games (UC1771\_2).
- Run baccarat games (UC1772\_2).
- Run the American and French roulette (UC1773\_2).
- Supervise table games in casinos (UC1774\_2).
- Communicate with different people in gaming establishments (UC1768\_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Complementary activities to running table games in casinos (MF1769\_2).
- Running the blackjack game (MF1770\_2).
- Running draw poker and straight poker games (MF1771\_2).
- Running baccarat games (MF1772\_2).
- Running French and American roulette (MF1773\_2).
- Supervising table games in casinos (MF1774\_2).
- Basic communication in gaming activities at casino tables (MF1768\_1).
- Practical training at the workplace in Gaming activities at casino tables (MP0355)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Open, run and the blackjack, draw poker with and straight poker games.
- Open, run and close baccarat games.
- Open, run and close American and French roulette.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the sector of games of chance and recreational gaming, in the sub-sector of gaming casinos, where card and ball games, among others, are run in accordance with current law.

The most pertinent occupations and positions are:

- Croupiers.
- Casino dealer.

<p style="text-align: center;"><b>Name and status of the national/regional authority providing accreditation/recognition of the certificate</b></p> <p>The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.</p>
<p style="text-align: center;"><b>Level of the certificate</b></p> <p>The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>
<p style="text-align: center;"><b>Grading scale/Pass requirements</b></p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> <li>- FAIL: 0 to 4.9</li> <li>- PASS-SATISFACTORY: 5 to 6.9</li> <li>- PASS-GOOD: 7 to 8.9</li> <li>- PASS-EXCELLENT: 9 to 10</li> </ul>
<p style="text-align: center;"><b>Access to next level of education/training</b></p> <p>This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.</p> <p>For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>
<p style="text-align: center;"><b>Legal basis</b></p> <p>Royal Decree 1695/2011 of 18 November, establishing three professional certificates in the professional family Hospitality and Tourism, which are included in the National Repertoire of Professional Certificates. (Appendix II, Code: HOTJ0110)</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

### Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
