3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to apply procedures for the administration and configuration of computer software and hardware, as well as to resolve any incidents that may occur in its normal operation; and to monitor performance and consumption, in accordance with the specifications received. This general competence is divided into the following **skills units** (UC):

- Install and configure the system software in microcomputing systems (UC0219_2).
- Maintain and regulate the physical subsystem in computer systems (UC0957_2).
- Execute administration and maintenance procedures on the system software and client applications (UC0958_2).
- Maintain the security of physical and logical subsystems in computer systems (UC0959_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Installation and configuration of operating systems (MF0219_2).
- Maintenance of the physical subsystem of computer systems (MF0957_2).
- Maintenance of the logical subsystem of computer systems (MF0958_2).
- Maintenance of security in computer systems (MF0959_2).
- Practical training at the workplace in computer systems operation (MP0286)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Install and configure the system software according to the protocols and procedures established by the company.
- Maintain and regulate the business computing system, as well as the security of the subsystems, in accordance with established procedures and supervised by the system administrator or person delegated by the administrator for this job.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work above all in the service sector, and mainly in companies or organisations that use computer systems for their administration; companies dedicated to the sale of computer equipment and services; companies providing technical computer assistance services; teleworking networks; the different public administration services, as part of the organisation's IT support. The most pertinent occupations and positions are:

- Microcomputing systems technician.
- Systems operator.
- Computer support technician.

The certificate is valid throughout Spain.</p>
<p style="text-align: center;">Level of the certificate</p> <p>The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>
<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10
<p style="text-align: center;">Access to next level of education/training</p> <p>This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.</p> <p>For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>
<p style="text-align: center;">Legal basis</p> <p>Royal Decree 1531/2011 of 31 October, establishing twelve professional certificates in the professional family Information and Communication Technology, which are included in the National Repertoire of Professional Certificates. (Appendix II, Code: IFCT0210). Amended by Royal Decree 628/2013 of 2 August, establishing four professional certificates in the professional family Information and Communication Technology, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established as Appendices I, II, III, IV, V, VI, VII, VIII, IX, X, XI and XII of Royal Decree 1531/2011 of 31 October, and as Appendices I, II, III, IV, V and VI of Royal Decree 686/2011 of 13 May.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
