3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to carry out the assembly and in-factory installation of machinery and industrial equipment and carry out maintenance and repairs on it, in conditions ensuring quality and safety levels. This general competence is divided into the following **skills units** (UC):

- Assemble and maintain machinery and mechanical equipment (UC0116_2).
- Maintain mechanical hydraulic and pneumatic systems for automated production lines (UC0117_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Assemble and maintain machinery and mechanical equipment (UC0116_2).
- Maintain mechanical hydraulic and pneumatic systems for automated production lines (UC0117_2).
- Practical training at the workplace in the maintenance and mechanical assembly of industrial equipment (MP0130).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Intervene in the start-up of the pneumatic and hydraulic mechanical equipment where there has previously been a breakdown or malfunction.
- Prepare programmes for the scheduling of maintenance activities.
- Carry out reprogramming of PLCs and robots in automated lines with mechanical and pneumatic/hydraulic elements.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the services for the maintenance of machinery and industrial equipment in the various productive sectors and in the sector of manufacture of equipment goods, in the processes of stationary mechanical assembly of machinery, in-factory assembly and installation of the machinery and in after-sales service, offering technical assistance to customers. The holder may also become a maintenance mechanic on automated production lines, being responsible for their maintenance. The following are an indication of some of the sub-sectors where this technician may work: the extractive industry; chemical industry; water and energy; metallurgy and the manufacture of metal products; the machinery and mechanical equipment construction industry; the textile industry; publishing and graphic arts; food and drink products; and fun fairs. The most pertinent occupations and positions are:

- Maintenance mechanic.
- Industrial assembly worker.
- Automated line maintenance worker.

The holder of this professional certificate has recognition of the basic level training in labour risk prevention, according to Annex IV of the Royal Decree 39/1997 of 17 of January approving the Labour Risks Prevention Act.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 715/2011 of 20 May, establishing ten professional certificates in the professional family Installation and Maintenance, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established in Royal Decree 1375/2009 of 28 August. (Appendix I, Code: IMAQ0108)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
