3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to receive and prepare raw materials, treat the milk and produce cheese, store and preserve the final product, following the technical specifications for the use of equipment and methods; maintaining the health and safety conditions, and respecting occupational safety and health and environmental protection regulations. This general competence is divided into the following **skills units** (UC):

- Carry out and conduct the reception, storage and prior treatment of the milk and other dairy raw materials (UC0027_2).
- Control and direct the processes for preparing cheese (UC0028_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Reception, storage and prior processing of the milk (MF0027_2).
- Production of cheese (MF0028_2).
- Practical training at the workplace in cheesemaking (MP0248)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Receive and store milk and other raw materials according to established procedures and carrying out the necessary controls.
- Carry out prior operations and processing on the milk.
- Control and direct the basic processes for producing cheese.
- Control the process and methods for maturing and preserving different kinds of cheese.
- Carry out cheese packaging, labelling and packing operations.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the cheesemaking industry, in the functional areas of reception, production (preparation of equipment, execution and control of operations, product quality) and storage (product storage and dispatch), in the dairy sector. The most pertinent occupations and positions are:

- Cheesemaker.
- Operator of machines for the production of cheese and similar products.
- Dairy product manufacturing worker.
- Milk processing worker.
- Dairy products production operator in general.
- Warehouse of dairy products operator

5. OFFICIAL BASIS OF THE CERTIFICATE
<p>Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.</p>
<p>Level of the certificate The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011). The European Qualification Framework (EQF) level:</p>
<p>Grading scale/Pass requirements The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10
<p>Access to next level of education/training This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family. For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>
<p>Legal basis Royal Decree 646/2011 of 9 May, establishing thirteen professional certificates in the professional family Food Industry, which are included in the National Repertoire of Professional Certificates, and updating the professional certificate established as Appendix I of Royal Decree 1380/2009 of 28 August. (Appendix III, Code: INAE0109)</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
