MAPN0211 COORDINATION OPERATIONS ON DECK AND IN FISH FARMS

3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to assign tasks to the crew on board and in the fish farm to carry out the orders received from a superior, coordinating maintenance operations, vessel's manoeuvres, fishing gear and equipment assembly and repair, as well as the classification, processing and preservation of fish captures and their loading in the tanks, following the hygiene, health and safety rules established. This general competence is divided into the following **skill units** (UC):

- Contribute to the operations on the deck of a fishing vessel (UC0010_1).
- Distribute and carry out the operations of maintenance, manoeuvres on deck and fishing, assembly and repair of fishing gear and equipment, and handling of catches (UC1894_2).
- Distribute and execute the operations on the fish farm and loading of catches (UC1895_2).
- Act in maritime emergencies and apply occupational safety rules (UC0733_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Work on deck on a fishing vessel (MF0010_1).
- Fishing and deck operations (MF1894_2).
- Fish farming operations (MF1895_2).
- Safety and first aid on board (MF0733_1).
- Practical training at the workplace in coordination operations on deck and in fish farms (MP0369).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Take part in all the processes of loading, distribution and unloading of catches in the cold storage and tanks, as well as the processes and surveillance of their preservation conditions, until their unloading in the port.
- Take part in all the processes involved in moving the catches from the fish farm to the tanks and in monitoring the temperature and humidity of the tanks until the unloading of the fish in the port.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the maritime-fisheries sector, and specifically in the productive activities consisting of: extractive fisheries; Industrial fishing farms; and auxiliary fishing industries (net factories, handling of fish products). The most pertinent occupations and positions are:

- Boatswain on a fishing vessel.
- Boatswain on a freezing vessel (fishing).
- Net handler.
- Fishing sailor.
- Hand net maker.
- Seaman.

The related occupations have specific requirements established in both national and regional regulations.

The holder of this professional certificate can be recognised by the title of fishing sailor according to Royal Decree 36/2014, which regulates the professional titles of fishing sector, following the established procedure and the authorised centers.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1774/2011 of 2 December, establishing four professional certificates in the Professional Family of Maritime and Fishing Industries, which are included in the National Repertoire of Professional Certificates. (Appendix I, Code: MAPN0211).

Amended by Royal Decree 622/2013 of 2 August, establishing two professional certificates in the Professional Family of Maritime and Fishing Industries, which are included in the National Repertoire of Professional Certificates and update the professional certificates established in Appendices I, II and III of Royal Decree 1533/2011 of 31 October, and as Appendices I, III and IV of Royal Decree 1774/2011 of 2 December.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
