MAPN0212 HANDLING OF WATERCRAFTS FOR WATER LIFE SAVING

3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to operate, for commercial purposes, watercrafts of less than 10 meters in length and up to 12 passengers, within inland waterways and coastal areas, with a power adequate to the vessel and ensuring the safety and health conditions of the crew, third parties, and respectful to the environmental conditions. This general competence is divided into the following **skill units**(UC):

- Perform auxiliary maintenance, conservation and control of provisions in watercrafts for water lifesaving activities (UC2048_2).
- Apply specific techniques of watercrafts handling for water lifesaving activities (UC2049_2).
- Apply specific swimming techniques in an effective and safety way (UC0269_2).
- Carry out watch keeping and handling of the vessel (UC0011_1).
- Act in maritime emergencies and implement safety standards at work (UC0733_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Maintenance, conservation and control of motor boats and personal watercrafts for water lifesaving (MF2048_2).
- Operating of motorboats and personal watercrafts for water lifesaving (MF2049_2).
- Swimming (MF2069_2).
- Watch-keeping navigation and handling of vessels (MF0011_1).
- Safety and first aid on board (MF0733_1).
- Practical training at the workplace in handling of watercrafts for water lifesaving (MP0530).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Participate in the operations of preparation of watercrafts for their operability taking into account the occupational risks prevention measures.
- Carry out the maintenance and repair of motor boats and personal watercrafts, taking into account the occupational risks prevention.
- Brace to sea, navigate and do the manoeuvres with security and rescue the shipwrecked and/or accidents following established protocols.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate exercises may work in the service sector where lifesaving activities are developed, sports, tourism and leisure and free time. The most relevant occupations and work positions are:

- Deck seafarer (except fishing).
- Bridge sailor.
- Boatmaster for ships up to 10 m. length in lifesaving teams.
- Boatmaster for ships up to 10 m. length in units of water lifesaving intervention.

The related occupations have specific requirements established in both national and regional regulations.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 988/2013 of December 13th, by which nine professional certificates of the Professional Family of Maritime and Fishery Industry included in the National Repertoire of professional certificates are established, and the professional certificates established as Appendix IV of the Royal Decree 1774/2011, of December 2nd and Appendix III of Royal Decree 1533/2011 of October 31st are updated. (Appendix IV, Code: MAPN0212)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
