3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to prepare, manage and promote projects for physical/sports and recreational activities, and organise, encourage and direct events and activities involved, aimed at all kinds of participants, and adapted to the nature of the environment and the characteristics and expectations of those taking part, guaranteeing safety at all times and achieving the complete satisfaction of participants, within the cost limits planned. This general competence is divided into the following **skills units** (UC):

- Prepare, manage, promote and evaluate projects of physical/sports and recreational activities (UC1658_3).
- Organise and encourage physical/sports and recreational events, activities and games for all kinds of participants (UC1659_3).
- Organise and develop cultural activities with the aim of stimulating tourist and recreational interest (UC1095_3).
- Organise and develop evenings and spectacles as entertainment (UC1096_3).
- Be a first responder in case of an accident or emergency situation (UC0272_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Projects of physical/sports and recreational interest (MF1658_3).
- Events, activities and games of physical/sports and recreational interest (MF1659_3).
- Cultural workshops and activities with the aim of stimulating tourist and recreational interest (MF1095_3).
- Evenings and spectacles for entertainment (MF1096_3).
- First aid (MF0272_2).
- Practical training at the workplace in physical/sports and recreational activities (MP0408)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Collaborate in the preparation of physical/sports and recreational activities linked to the centre's general programming.
- Prepare and/or adapt programmes of physical/sports and recreational activities for different types of groups, reflecting the methodology of application and the criteria for the selection of activities, workshops and events.
- Analyse the facilities within the enterprise in question and carry out the necessary maintenance on the specific equipment and materials used for physical/sports and recreational activities as entertainment.
- Apply communication and customer service techniques.
- Collaborate in the application of techniques for expression, representation, scenography and decoration in different types of evenings and spectacles.
- Organise cultural workshops and activities within establishments offering tourist and recreational activities.
- Collaborate on the management and animation of events and sessions of physical/sports and recreational activities, describing and demonstrating efficiency in the strategies of motivation of the participants, and the correct use of material and equipment, taking into account the type of participants, their expectations, age and nationality.
- Collaborate on the actions needed for mounting, preparing and carrying out activities at evenings and spectacles within the framework of entertainment projects.
- Collaborate on the application of techniques and methods of evaluation of the activities, events, evenings and spectacles, and make subsequent proposals for the improvement of the entertainment programme.
- Identify the first aid required in situations of the most frequent injuries or pathologies and collaborate in its application in accordance with established protocols.

3. PROFILE OF SKILLS AND COMPETENCES

- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the public or private sector in the following areas: Sports and Recreational sports; Leisure, free time and tourism. The most pertinent occupations and positions are:

- Physical/sports and recreational leader.
- Coordinator of sports entertainment activities.
- Monitor of physical/sports and recreational activities in camps.

The related occupations have specific requirements established in the national and regional regulations.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1076/2012 of 13 July, establishing six professional certificates in the professional family Physical and Sports Activities, which are included in the National Repertoire of Professional Certificates. (Appendix V, Code: AFDA0211)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
