3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to set up and manage the staging of live performances in changing circumstances, in accordance with the artistic project, the characteristics of the venue, the technical, financial and human conditions, and safety for the spectators, artists and workers, by organising, supervising, installing and operating the different systems of professional machinery. This general competence is divided into the following **skills units** (UC):

- Take part in setting up the staging plan for the live performance (UC1711_3).
- Plan and manage the machinery plan for a live event or performance in changing conditions, coordinating and supervising its execution (UC1713_3).
- Assemble, disassemble and carry out maintenance on the machinery and staging elements for a live event or performance in changing operating conditions (UC1713_3).
- Assist rehearsals and performances, managing the machinery equipment and stage elements under changing operating conditions (UC1714_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Dramaturgy, staging and stage space for a live performance (MF1711_3).
- Planning and management of the machinery used in the staging plan for a live performance under changing operating conditions (MF1712_3).
- Stage machinery processes applied to live performances (MF1713_3)
- Management of machinery equipment and stage elements at rehearsals and performances for a live performance under changing operating conditions (MF1714_3).
- Practical training at the workplace in stage machinery for live performances (MP0280)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Cooperate in determining the assembly plans for the machinery, adapting to the work plan, and the technical, artistic and production requirements established beforehand.
- Collaborate on the coordination and supervision of the assembly and disassembly of staging elements according to the requirements established in the machinery plan.
- Take part in the assembly and disassembly of stage elements according to the requirements established in the machinery plan.
- Take part in the construction of stage designs based on documentation provided, to use in rehearsals or to complement and adapt the staging to the conditions of the space in which it is located.
- Take part in drafting the machinery logbook during the rehearsals, taking note of the instructions of the director and head of section.
- Take part in the service provided for the performance in accordance with the instructions from the stage director and head of section.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the following sectors: performing arts: theatre, dance, opera, zarzuela, musicals, review, circus, etc; Live music: Acoustic and electro-acoustical concerts of classical, pop, rock, jazz, recitals, etc; Events: Catwalks, conventions, conferences, meetings, celebrations, fun fairs, sports, advertising, etc; and Exhibitions: fairs, exhibitions, museums, events to promote the cultural heritage, etc.

The most pertinent occupations and positions are:

- Machinery manager in live performances.
- Curtain machinist.
- Stage machinist.
- Stand assembler.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1521/2011 of 31 October, establishing six professional certificates in the professional family Arts and Crafts, which are included in the National Repertoire of Professional Certificates.(Appendix VI, Code: ARTU0110)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
