## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to protocolize and carry out aesthetic facial and body treatments, taking into account the diagnosis and customer's needs and requirements, applying cosmetic, beauty-electrotherapy and massage and lymphatic draining techniques in accordance with health and safety criteria and quality. This general competence is divided into the following **skills units** (UC):

- Perform the diagnosis and personalised beauty protocols design (UC0796\_3).
- Perform manual and/or mechanical massages with aesthetic purposes (UC0063\_3).
- Perform manual and/or mechanical lymphatic drainage with aesthetic purposes (UC0790\_3).
- Apply cosmetic electrotherapy techniques integrating them into specific aesthetic treatments (UC0797\_3).
- Perform beauty treatments coordinating the application of different cosmetic, aesthetic-electrotherapy and manual techniques (UC0798\_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Aesthetic diagnosis and protocols (MF0796\_3).
- Manual and mechanical aesthetic massages (MF0063\_3).
- Manual and mechanical aesthetic lymphatic drainage (MF0790\_3).
- Electro-aesthetics (MF797\_3).
- Comprehensive beauty treatments (MF0798\_3).
- Practical training at the workplace module in Aesthetic treatments (MP0294)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Apply methods of beauty diagnosis for the application of beauty treatments, with the aim of evaluating the characteristics and conditions of the customer, complying with the rules on safety and health.
- Select and prepare the physical spaces, technical means, products and cosmetics needed to carry out the treatment.
- Apply techniques of preparation and customer service during the provision of comprehensive beauty services.
- Skilfully give manual and mechanical beauty massages in each anatomical area, selecting the movements to define the various massage techniques.
- Perform manual and mechanical lymphatic drainage of each anatomical area under adequate hygiene and safety conditions.
- Perform manual beauty lymphatic drainage techniques following the cosmetic medicine and surgery treatments and operations under adequate hygiene and safety conditions.
- Apply basic electrostatic techniques for skin hygiene and cleanliness, under adequate hygiene and safety conditions.
- Apply the electrostatic techniques based on electrical currents to carry out established beauty treatment, under adequate hygiene and safety conditions.
- Apply electrostatic techniques based on the application of electromagnetic radiation under adequate hygiene and safety conditions.
- Apply mechano-therapy techniques to perform established beauty treatment under adequate hygiene and safety conditions.
- Carry out facial and body treatments that include different cosmetological, electrostatic and manual techniques.
- Apply cosmetic techniques associated with pre- and post-surgical treatment and cosmetic medicine under

- adequate hygiene and safety conditions.
- Identify the parameters that determine the quality of the process in the application of beauty treatments.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in beauty and hairdressing companies as self-employed worker or employee, in beauty salons, cosmetic medicine and surgery; and in the areas of hairdressing, aesthetics and parapharmacies, hotels, gymnasiums, and homes for the elderly and spas. The work is in the services sector, in the area of beauty treatment and/or hairdressing. The most pertinent occupations and positions are:

- Aesthetician.
- Technical coordinator of beauty treatments.
- Specialist in beauty massage and lymphatic drainage.
- Advisor and demonstrator of beauty products and apparatus.
- Specialist in facial and body beauty treatment.

### 5. OFFICIAL BASIS OF THE CERTIFICATE

#### **Name and status of the national/regional authority providing accreditation/recognition of the certificate**

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

#### **Level of the certificate**

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

#### **Grading scale/Pass requirements**

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

#### **Access to next level of education/training**

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

#### **Legal basis**

Royal Decree 1527/2011 of 31 October, establishing two professional certificates in the professional family Personal Image, which is included in the National Repertoire of Professional Certificates. (Appendix II, Code: IMPE0210).

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

### Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
