3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to assist library users, carrying out the tasks of information and education, lending and maintenance and conservation of the library collection, and carrying out activities of cultural and library outreach, taking into account criteria of quality. This general competence is divided into the following **skills units** (UC):

- Inform and educate library users (UC2022_3).
- Administer and maintain the library collection (UC2023_3).
- Carry out the library lending service (UC2024_3).
- Carry out cultural and library outreach activities (UC2025_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Information and education for library users (UC2022_3).
- Administration of the library collection (MF2023_3).
- Library lending service (MF2024_3).
- Cultural and library outreach (MF2025_3).
- Practical training at the workplace in monitoring of library lending services (MP0405)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Receive, inform and educate library users, in partnership with the corresponding person responsible.
- Collaborate in the selection, acquisition and incorporation of resources to the library collection.
- Organise the collection on the storage devices in the library and collaborate on the maintenance of catalogues, repositories, websites, etc.
- Carry out the lending and return, reservation and/or renewal of library resources.
- Preserve and conserve the library resources, carry out inventories and dispose of library resources.
- Support cultural outreach and reading promotion activities, and collaborate in library outreach activities.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the services sector linked to the scientific-technological, sociocultural and educational area. The most pertinent occupations and positions are:

- Library assistant.
- Library helpdesk assistant.
- Specialist librarian assistant.

The certificate is valid throughout Spain.</p>
<p style="text-align: center;">Level of the certificate</p> <p>The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>
<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10
<p style="text-align: center;">Access to next level of education/training</p> <p>This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.</p> <p>For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>
<p style="text-align: center;">Legal basis</p> <p>Royal Decree 1697/2011 of 18 November, establishing five professional certificates in the professional family Sociocultural and Community Services, which are included in the National Repertoire of Professional Certificates. (Appendix V, Code: SSCB0111)</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
